**2. COMPOSITION/INFORMATION ON INGREDIENTS**

A lubricating grease consisting of highly-refined mineral oil and additives.  
The highly refined mineral oil contains <3% (w/w) DMSO-extract, according to IP346.  
The highly refined mineral oil is only present as additive diluent.

**3. HAZARDS IDENTIFICATION**

<b>Emergency Overview</b>	
<b>Appearance and Odour</b>	: Blue-green. Semi-solid at room temperature. Slight hydrocarbon.
<b>Health Hazards</b>	: High-pressure injection under the skin may cause serious damage including local necrosis.
<b>Safety Hazards</b>	: Not classified as flammable but will burn.
<b>Environmental Hazards</b>	: Not classified as dangerous for the environment.

**4. FIRST-AID MEASURES**

- General Information** : Not expected to be a health hazard when used under normal conditions.
- Inhalation** : No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.
- Skin Contact** : Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop. If persistent irritation occurs, obtain medical attention. Obtain medical attention even in the absence of apparent wounds.
- Eye Contact** : Flush eye with copious quantities of water. If persistent irritation occurs, obtain medical attention.

Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.

For continuous contact we recommend gloves with breakthrough time of more than 240 minutes with preference for > 480 minutes where suitable gloves can be identified. For short-term/splash protection we recommend the same, but recognise that suitable gloves offering this level of protection may not be available and in this case a lower breakthrough time may be acceptable so long as appropriate maintenance and replacement regimes are followed. Glove thickness is not a good predictor of glove resistance to a chemical as it is dependent on the exact composition of the glove material.

- Acute Toxicity** : Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be practically non toxic: LL/EL/IL50 > 100 mg/l (to aquatic organisms) LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract.
